



1999 Miramar acquired initial interest; spent \$170 million on exploration and resource expansion in 9 years

Miramar acquired by Newmont (pre-market crash).

Post market crash, Newmont sells mothballed project to TMAC.

TMAC poured first bar of gold in 1st quarter

TMAC's sale to Shandong Mining Co. Ltd. rejected by federal government in December

Agnico Eagle steps-in to complete acquisition of TMAC








ORO vs DORIS: SAME STRUCTURAL SETTING


North Arrow

- Doris mineralization occurs at a NE flexure of the Doris Volcanics coincident with a regional NE trending structure.
- A similar NE flexure of the Doris
 Volcanics within the ORO property also coincident with a NE trending structure = POTENTIAL TARGET AREA
- Several additional NE trending structures throughout the property = POTENTIAL TARGET AREAS WHERE COINCIDENT WITH Fe-Ti BASALT / Mg BASALT CONTACTS

EXPLORATION – WAY FORWARD

- Time is right for exploration in 2021 with focus on:
 - Areas of Structural Complexity
 - Areas of Overburden cover next to Fe-Ti basalts
 - Beneath diabase sill?
- With or without a Joint Venture partner

"Early-stage exploration—that's where the true value gets created...We're bumping our exploration budget by 50% or \$50 million in 2021. And that was prior to acquiring TMAC," Agnico Eagle CEO, Sean Boyd, Jan. 15, 2021, Kitco

- Compliment to \$5.6M bulk sample at Naujaat
 - Fully funded by partner
 - Starts early June
 - Initial results fall 2021
 - NAR retain 60%
